 - Delegates will be required to answer some COVID related questions.
 - Masks will be required (unless you have a valid health reason and present proof of the same, such as a doctor's note)
 - Personal hand sanitizer will be provided to each Delegate.
 - Seats will be separated per Health guidelines. DO NOT MOVE THEM!
 - A speaker system will be present but will not be the quality to which we are accustomed at the hotels. Therefore, the front three (3) rows will be reserved for those who have a hearing impairment.
