

DEDICATIONS

TAHOE TROUT FARM

Originally called Upham's Pond, the Tahoe Trout Farm was founded in 1946 in Johnson Meadows on Trout Creek, a summer fishing, hunting and gathering ground for the Washoe Indians.

The land was purchased in 1860 by the Johnson family for summer grazing of their cattle. In the winter the cattle were moved to their Gardnerville, Nevada ranch. In 1872, Mr. Charles Johnson caught a native Lake Tahoe cutthroat trout that tipped the scales at 29 ½ pounds.

E.J. Vallier a 5th generation Californian, and his wife, Jacqueline, were customers at the ponds in the 1950s. They purchased Tahoe Trout Farm in 2012.

In 1886, Captain T.J. Vallier, E.J.'s great-grandfather, became the youngest captain of the Bar Pilots Association, and in 1907 he was a charter member of the Pioneers of Alaska, Nome Igloo #1.

THE BURDELL BUILDING

The Burdell Building was constructed in 1897 by the Burdell family. At the time of construction, it had the longest continuous frontage of any building in Sonoma County, and would become the hub of the booming poultry and dairy industry, with the ability to keep eggs, milk, butter and cheese fresh, and to freeze poultry, while also producing five tons of ice, per day, for the businesses and homes in the area.

Over the years the Burdell Building has been the home of the Burdell Creamery, the Petaluma Ice and Cold Storage Company, the Western Refrigerating Company, and Western Dairy Products, Inc. The building was also occupied by the Petaluma Gas & Electric Company, which provided electricity for Petaluma from 1897 to 1907.

Currently owned by David Martin and Jim Nelson of The Ice House LLC, who, through Creedence Corporation, has restored and maintained the historic nature of this property. Today it is occupied by many small businesses.

BRODERICK-TERRY DUEL

UNITED STATES SENATOR DAVID C. BRODERICK, AND CALIFORNIA CHIEF JUSTICE DAVID S. TERRY, FOUGHT A DUEL ON THIS GROUND IN THE EARLY MORNING OF TUESDAY, SEPTEMBER 13, 1859. BRODERICK'S FIREARM DISCHARGED, PREMATURELY, INTO THE GROUND, FORCING HIM TO STAND WHILE TERRY SHOT AND WOUNDED HIM. HE DIED THREE DAYS LATER. THE AFFAIR MARKED THE END OF DUELING IN CALIFORNIA, AND WAS THE LAST NOTABLE DUEL IN THE UNITED STATES.

THE PUBLIC WAS LARGELY REVOLTED BY WHAT THEY PERCEIVED AS AN ASSASSINATION OF THE ANTI-SLAVERY SENATOR BRODERICK BY THE PRO-SLAVERY TERRY, SOLIDIFYING CALIFORNIA'S LOYALTY TO THE UNION DURING THE CIVIL WAR.

SENATOR BRODERICK OCCUPIED THE POSITION MARKED BY THE PILLAR TO THE SOUTHEAST. WHILE JUDGE TERRY STOOD AT THE POSITION DESIGNATED BY THE NORTHWEST PILLAR. SPECTATORS OCCUPIED THE HILL TO THE NORTH.

CALIFORNIA HISTORICAL LANDMARK No. 19

HISTORIC RAE HOUSE

GALT PIONEER, JOHN RAE, BUILT HIS QUEEN ANNE COTTAGE-STYLE VICTORIAN HOME IN 1868. JOHN WAS A MAJOR GALT-AREA RANCHER WHO ORIGINALLY CAME FOR THE GOLD, THEN BECAME AN INTERIOR PLASTER TRADESMAN, AND WORKED AT THE STATE CAPITOL. JOHN'S DAUGHTER, ALICE, A GALT HIGH SCHOOL GRADUATE, A 30-YEAR TEACHER IN THE SCHOOL DISTRICT, AND CITY CLERK IN 1955, INHERITED THE HOUSE. SHE LIVED THERE HER ENTIRE LIFE AND PASSED IN 1987. OVER THE YEARS, THE HOUSE WAS ABANDONED AND FELL INTO DISREPAIR, THE LAND WAS BOUGHT BY DEVELOPERS, AND THE HOUSE WAS SCHEDULED FOR DEMOLITION. WORD GOT OUT, AND A "SAVE THE RAE HOUSE" CAMPAIGN WAS INITIATED AND SUPPORTED BY THE WHOLE COMMUNITY. IT WAS A SUCCESS, AND THE DOORS OPENED TO THE NEW MUSEUM ON JUNE 9, 1991.

William Howard "Pete" Snell 1914-1956

Born in Reno, Nevada, Pete Snell enlisted in the United States Army in 1940, and served in the Pacific Theater during World War II, specializing in aviation signal work. Snell began racing sports cars in 1951.

On this site, while driving his Triumph TR-3 in the Redwood Empire Sports Car Race at the Arcata airport on August 19, 1956, Snell was bumped by another car and lost control, flipping several times. Snell's state-of-the-art helmet shattered and, an hour later, he died of traumatic head injuries at Trinity Hospital in Arcata.

Dr. George Snively, track physician at Arcata, was studying the effectiveness of the helmets being used by the drivers. Seeing first-hand how poorly the existing headgear performed, Snively began formal research into advanced head protection.

The Snell Memorial Foundation was established in 1957, and financed Dr. Snively's work to develop helmet testing and certification standards. More than sixty years later, with standards surpassing the United States Department of Transportation, the Snell Memorial Foundation remains a leader in testing, certification, and improvement of headgear for motorsports and many other activities where helmets are used. The Sports Car Club of America, and other organizations, now require the use of helmets approved by Snell.

Old Eureka Mine

Established 1852

The Old Eureka Mine was first opened in 1852 and comprised the Amador, Maxwell, Alpha, and Railroad claims. At various times it was known as the Hayward, Eureka, Hetty Green, Badger and Wolverine, and Amador Consolidated mines.

One ore shoot encountered a vein of metallic gold as large as 3/8" thick, that was also struck in the adjoining Badger Mine, 1000 feet to the south. This is the only instance of a true vein of metallic gold, not disseminated gold, having been found in California.

Alvinza Hayward, for whom the city of Hayward is named, acquired control of both the Old Eureka and Badger mines in 1859 and consolidated them under the Old Eureka Mine. He incorporated the mine, and sold shares of its stock, making the Eureka the first mine in California to be so incorporated.

In 1866 it was reported that 30,000 tons of ore yielded \$27 per ton at a working cost of \$5 per ton, but by 1875 the ore was declining in quality. In 1886, after the mine had attained a depth of about 2000 feet and had produced about \$16,000,000, it was closed and remained idle for a period of 30 years.

Hetty Green, the "Witch of Wall Street," assumed control of the Old Eureka in 1902, but refused to operate or sell the property until 1916, when she finally sold out to a reconstituted Consolidated Amador Mining Company for \$500,000.

Consolidated spent another \$200,000 to reopen and rehabilitate the mine. They deepened the shaft to 3500 feet and drifts were run north and south, but this exploration failed to reveal paying ore.

All mining was shut down in 1942, but resumed in 1946, after the war. Due to increased costs, the mine finally closed in the early 1950s.

The Jackson-Plymouth district was the most productive mining district of the Mother Lode belt, with an estimated total production of about \$180 million.

The mine is now owned by Jeff Campbell, the 2023/2024 President of Native Sons of the Golden West, Amador Parlor No. 17, and his wife, Jessie.

CENTERVILLE BEACH CROSS

This cross was erected on a bluff overlooking Centerville Beach on September 11, 1921, by the Native Sons of the Golden West, Ferndale Parlor No. 93, to honor the 17 passengers and 21 crewmembers of the steamship SS Northerner, who perished on January 5, 1860.

The paddle wheeler struck submerged rocks two miles offshore and was beached near the original site.

This cross was broken from its base during the 1992 Cape Mendocino Earthquakes, and a new cross was erected in 1995 to replace it. Due to imminent collapse from erosion, the 1995 cross was moved to Centerville Beach parking area.

In 2023, the original cross was salvaged and moved to this site with funds provided by the NSGW Historical Preservation Foundation.

The Centerville Beach Cross is California Historical Landmark No. 173.

Auburn's Chinese Cemetery

This site was purchased in 1899 by Charles Yue and Mar Bing Toy to serve as a cemetery for the Chinese community. Despite contributions to the area, Chinese were excluded from burial at most local cemeteries; this site provided a temporary and permanent final resting place.

Central to this site is the altar platform and "burner." Chinese tradition was to burn symbols of money and personal effects here to assure a safe transit to the afterlife. Food, spirits, and joss sticks were also placed on the altar.

Burials here were only meant to be temporary as Chinese custom is to be interred with ancestors in their native village. Repatriation of remains to China was an elaborate affair managed by the "chief scraper and gatherer of bones." He was in charge of gathering the exhumed bones, cleaning, and disinfecting them, then placing them orderly in a zinc or tin box or urn. Bones were then sealed, labeled and arrangements made for shipment to China. Many of the immigrants who came to California and Auburn were from the Sze Yup District of China.

The last known large removal of bones was in 1913 by the Chinese Six Companies and the Mar family. Thirtyone bodies were returned to China. Other smaller shipments of bones were made about the same time.

This plaque recognizes the Historic Chinese Cemetery and honors the Chinese pioneers in America who contributed to the wealth and growth of the Auburn community and the State of California.

1866-1956

The pioneer town of Monticello was founded in 1866 when the E.A. Peacock Hotel was erected. In 1867, I.N. Van Nuys built the general merchandise store which housed the post office. The Putah Creek bridge, built in 1896, was the largest stone bridge west of the Rocky Mountains. In December 1956, the last building was razed in preparation for the creation of Lake Berryessa behind the Monticello Dam.

LOS ALAMITOS LOS CERRITOS

THIS PLAQUE MARKS THE DIVIDING LINE BETWEEN THE TWO RANCHOS ON WHICH LONG BEACH WAS SUBSEQUENTLY BUILT. ORIGINALLY A PART OF THE RANCHO LOS NIETOS SPANISH LAND GRANT TO MANUEL NIETO IN 1784, WHICH WAS PARTITIONED BETWEEN THE HEIRS BY CONFIRMATION GRANTS FROM THE MEXICAN GOVERNMENT IN 1834.

RESOLUTIONS

Resolution 147-01 Grand Parlor Annual Session Fund

WHEREAS Article X of the Constitution and Laws of the Grand Parlor identifies the several funds required to operate the order; and

WHEREAS the intent behind the creation of such funds is to provide a reasonable control over the distribution of Grand Parlor moneys to ensure continuing solvency of the order; and

WHEREAS the Grand Parlor Meeting Fund, as described in Part A, Revenue, Section 5(f), is intended to support only the necessary expenses of conducting the Grand Parlor meeting each year, while actual expenses are variable based on an 'as yet' unspecified number of delegates in attendance each year; and

NOW THEREFORE BE IT RESOLVED that the Constitution and Laws of the Grand Parlor, Article III, How Composed, Section 1, be amended by adding the following;

Section 1. Committee on the Grand Parlor Annual Session.

NOW THEREFORE BE IT FURTHER RESOLVED that the Constitution and Laws of the Grand Parlor, Article III, How Composed, Section 3, be amended as follows;

Section 3. Registration

- (a) All members of the Grand Parlor shall register at each Grand Parlor session, and upon registration shall pay a fee fixed by the *Committee on the Grand Parlor Annual Session* local committee, provided said fee shall not exceed the sum of one hundred *forty-five* twenty-five dollars (\$145.00 125.00).
- (1) if this total amount is not needed to meet the obligations of the local committee to entertain the delegates to the Grand Parlor Annual Session, then only such amount as is needed shall be charged.
- (2) Each Grand Parlor Committee must file a financial report to be provided to the members no later than the end of the calendar year.
- (3) The registration fee shall be adjusted each year, based on the annual January U.S. Bureau of Labor Statistics Consumer Price Index, San Francisco Area, rounded to the nearest dollar.

NOW THEREFORE BE IT FURTHER RESOLVED that the Constitution and Laws of the Grand Parlor, Article X, Revenue and Expenditure of Funds, Part A, Revenue, Section 5(f), be amended as follows;

- Section 5. The Grand Parlor herewith creates the following annual funds
 - "(f) Grand Parlor Meeting Annual Session Fund, which fund shall be financed by the registration fees paid by delegates officers, and others attending an annual appropriation of the Grand Parlor Annual Session.
 - (1) This fund shall be used to defray the expenses of host the annual meeting of the Grand Parlor.
 - (2) The Committee on the Grand Parlor Annual Session shall have jurisdiction over this fund, subject to audit and approval by the Committee on Finance.
 - (3) The funds shall be used for the Grand President's opening reception, banquet, BBQ, incoming Grand President's reception, and general entertainment of the delegates. In no circumstance shall Committee, nor fund, be used for the pre-banquet Grand President's private party.

NOW THEREFORE BE IT FURTHER RESOLVED that the Constitution and Laws of the Grand Parlor, Article VIII, Section 1(a)7, add the following;

(7) Committee on the Grand Parlor Annual Session. Committee of 5 members. Three (3) appointed members shall each serve for a term of three (3) years with the then Grand 2nd Vice President making an annual appointment for the newest member of the Committee. The member

of the Board serving the third year shall be Chairman of the Board. The Grand Treasurer and Grand Secretary shall also serve on the committee.

NOW THEREFORE BE IT FURTHER RESOLVED that the Constitution and Laws of the Grand Parlor, Article IX, Section 1(a)7, add the following;

- (7) The Committee on the Grand Parlor Annual Session shall:
 - (i) Locate and secure a suitable location for the Grand Parlor Annual Session.
 - (ii) Negotiate a reasonable contract for the Grand Parlor Annual Session.
 - a) The Grand Secretary as Chief Operating Officer of the Grand Parlor shall be the signatory to the contract on behalf of Grand Parlor.
 - (iii) Provide for the registration of delegates.
 - (iv) Provide for the housing of the delegates.
- (v) Provide for the Grand President's opening reception, banquet, BBQ, incoming Grand President's reception, and general entertainment of the delegates. In no circumstance shall Committee, nor fund, be used for the pre-banquet Grand President's private party.

Resolution 147-02 Duties of the Grand Secretary

WHEREAS the Constitution and Laws of the Grand Parlor, Article VI, Duties of Officers, Section 4(g) currently reads "report to the Grand Parlor all Subordinate Parlors delinquent in the payment of moneys due to the Grand Parlor or in the filing of semi-annual reports"; and

WHEREAS the Constitution and Laws of the Grand Parlor, Article VI, Duties of Officers, Section 4(v) currently reads "provide a monthly report to the Grand President, Membership Committee, Supervising District Deputy Grand Presidents and all Subordinate Parlors, detailing Parlors delinquent in per capita tax payments and late in filing semi-annual reports"; and

WHEREAS these two sections are largely redundant;

NOW THEREFORE BE IS RESOLVED that the Constitution and Laws of the Grand Parlor, Article VI, Section 4(g) be eliminated in its entirety.

BE IT FURTHER RESOLVED that the Constitution and Laws of the Grand Parlor, Article VI, Section 4(v) be amended to read as follows

provide a monthly report to the Grand President, Membership Committee, Supervising District Deputy Grand Presidents and all Subordinate Parlors detailing **all moneys due to the Grand Parlor, including** Parlors delinquent in per capita tax payments, and late in filing of semi-annual reports; and

BE IT FURTHER RESOLVED that the subsections be renumbered accordingly.

WHEREAS the Constitution and Laws of the Grand Parlor, Article VI, Duties of Officers, Section 9, defines the Grand Trustees; and

WHEREAS per Article VI, Section 16, of the Constitution and Laws of Grand Parlor, the Salary Committee includes the Chairman of the Grand Trustees, but this duty is not listed under the duties of the Grand Trustees;

NOW THEREFORE BE IT RESOLVED, that the Constitution and Laws of the Grand Parlor, Article VI, Section 9, be amended as shown;

Section 9. The Board of Grand Trustees:

(n) The Chairman of the Board of Grand Trustees shall serve as a member of the Salary Committee.

WHEREAS actually closing the accounts on March 31st would render it impossible for Grand Parlor to conduct any business for the final two months of the de facto fiscal year;

NOW THEREFORE BE IT RESOLVED that the Constitution and Laws of the Grand Parlor, Article VI, Section 6(e), be amended as shown; and

Section 6. The Grand Treasurer shall:

(e) have his accounts closed on the thirty-first (31) day of March preceding the annual session and submit them to the Committee on Finance and transmit via the Grand Secretary annually to the Subordinate Parlors a Financial Statement; in coöperation with the Grand Secretary, close his accounts at the end of each fiscal year, after all expenses have been reported and paid, submit them to the Committee on Finance, and submit a financial statement to the Grand Secretary for inclusion in the annual Proceedings of the Order;

Resolution 147-05 Hall Association Directors

WHEREAS the laws of this "*Hall Association*" provide that two of its directors shall be appointed annually by the Grand President of the Native Sons of the Golden West, and

WHEREAS the authority to make these appointments and the duties of such appointed directors each year is not currently addressed in the Constitution and Laws of The Native Sons of the Golden West,

NOW THEREFORE BE IT RESOLVED that the Constitution and Laws of the Grand Parlor, Article VI, Section 1 be amended by the addition a new subsection as follows:

(tbd) within the first calendar quarter of each year, appoint two members to the board of the San Francisco Hall Association, which may be the Grand President and/or a Grand Vice President of the Native Sons of the Golden West.

BE IT FURTHER RESOLVED that the Constitution and Laws of the Grand Parlor, Article VIII, Section 1(c) be amended by the addition of a new subsection as follows:

(7) Hall Association Committee of two members which shall be the currently appointed members until their reappointment or replacement during the next year's first calendar quarter.

BE IT FURTHER RESOLVED that the Constitution and Laws of the Grand Parlor, Article IX, Section 1(c) be amended by the addition of a new subsection as follows:

(7) The Hall Association Committee shall represent the interests of Grand Parlor as pertains to all business of the San Francisco Hall Association and report to the Grand Parlor any business conducted therein.

WHEREAS the Constitution and Laws of the Grand Parlor, Article V, Part A, Section 2, defines the process for nominating candidates for Grand Office; and

WHEREAS the procedure, as defined, is not the process followed in practice; and

WHEREAS it is the mission of the Constitution Revision Committee to assure that the Constitution is clear, correctly and consistently organized, concise, unbiased, and understandable to all users;

NOW THEREFORE BE IT RESOLVED that the Constitution and Laws of the Grand Parlor, Article V, Part A, Section 2, be amended as shown; and

Section 2. Judge of Election shall conduct the following nomination procedures: Nominating procedure:

- (a) Under the auspices of the Judge of Elections, Nnominators of Grand Officers candidates for contested offices shall draw lots to determine who shall speak first in what order the candidates shall be nominated. The Grand Secretary shall be instructed to east a ballot to elect for any uncontested office.
- (b) The-Grand President shall set the time for the nominators' and candidates' presentations.
- (b)(1) Each nominator shall be allowed no more than three (3) minutes to introduce his candidate.
- (e)(2) Each candidate shall be allowed no more than five (5) minutes to present his accomplishments and ideas or platform.

- (i) For those offices, which are uncontested, upon a motion to waive; only the nominators' speech is in order.
- (d) The Judge of Election shall arrange for a time for both the nominators' and candidates' presentations.
- (c) The Grand President shall invite nominations for each office, in succession. Nominations shall continue for each office until the Grand President has invited nominations, without response, at least two times, at which point the nominations for that office shall be closed.
- (d) The Grand Secretary shall be instructed to cast a ballot-to-elect for any uncontested office(s).

BE IT FURTHER RESOLVED that the Constitution and Laws of the Grand Parlor, Article IX, Section 1(a)(6), be amended by the addition of the following;

(6) Constitution Revision Committee shall:

(tbd) present resolutions to the office of the Grand Secretary at least 90 days in advance of the Grand Parlor Annual Session, according to Article XIV, Section 1(a), of the Constitution and Laws of the Grand Parlor.

Resolution 147-08 Semi-Annual Reports

WHEREAS the Constitution and Laws of the Grand Parlor, Article XI, Subordinate Parlors, Sections 8 through 10, address the filing of semi-annual reports; and

WHEREAS the user of this Constitution shouldn't have to jump around like a flea in a hot skillet, looking for all of the information on a given subject; and

WHEREAS it is the mission of the Constitution Revision Committee to assure that the Constitution is clear, correctly and consistently organized, logical, concise, unbiased, and understandable to all users;

NOW THEREFORE BE IT RESOLVED that the Constitution and Laws of the Grand Parlor, Article XI, Sections 8 through 10, be amended as shown and the remaining sections be renumbered accordingly;

Section 8. Semi-annual reports:

- (a) At the end of each semi-annual term, every Subordinate Parlor shall report to the Grand Parlor:
 - 1.• the total number in membership;
 - 2.• the amount of receipts and from what source(s);
 - 3.• the amount and purpose of disbursements;
 - 4.* the amount of money on hand;
 - 5.• the type and value of all assets, *including*:
 - the amount of cash on hand,
 - the value and type of investments,
 - a complete listing of all real property
 - 6.• the result of the election of current officers.

<u>Section 9.</u> (b) For failure to transmit a copy of such semi-annual report to the Grand Secretary within forty-five (45) days after the time of the first regular meeting in January and July of each year:

- (a)(1) the Parlor shall be subject to the provisions of Article XI, Section 13; and
- (b)(2) no Parlor shall be entitled to representation in the Grand Parlor when such Parlor is delinquent in its semi-annual reports.

Section 109, Taxes. Each subordinate parlor shall include with its semi-annual report a complete listing of all real property and other sources from which it receives income not related to its functions as a Native Son Parlor and shall file all necessary federal and state tax returns and, within 30 days of such filing, furnish the Grand Secretary a copy of each tax return covering such income which has been submitted to the Internal Revenue Service and the Franchise Tax Board of the State of California.

Resolution 147-09 Corporate Definitions

WHEREAS the Grand Parlor of the Native Sons of the Golden West became incorporated on the 23rd day of May, 1938; and

WHEREAS, as a corporation, corporate titles are a necessity when conducting business; and

WHEREAS the corporate Titles of CEO, COO, and CFO, have been adopted; and

WHEREAS the term "Grand Parlor" has become a catch all phrase with no clear corporate definition, and the terms "Fiscal Year", and others, are also undefined or scattered throughout the Constitution;

NOW THEREFORE BE IT RESOLVED, that the Constitution and Laws of the Grand Parlor, Article I, Name and Object, be amended to add a new Section 5, to read as follows.

Section 5. Definitions

- (a) <u>Grand Parlor Corporation</u>: Grand Parlor of the Native Sons of the Golden West, as incorporated in 1938.
- (b) <u>The Grand Parlor:</u> The Grand Officers, delegates, and other voting members as defined in Article III, Section 1, of this constitution.
- (c) <u>Grand Parlor Annual Session</u>: The annual meeting of the Native Sons of the Golden West defined in Article IV, Sections 1 and 2, of this Constitution
- (d) <u>Grand Parlor Office</u>: The business office of the Grand Parlor Corporation, located at 414 Mason Street, Suite 300, San Francisco, California.

- (e) The <u>Board of Grand Officers</u>: The statutory Board of Directors of the Grand Parlor Corporation, as defined in Article V, Part B, Section 6(a).
- (f) <u>CEO. COO.</u> and <u>CFO</u>: The corporate officers of the Grand Parlor are defined in Article V, Part B, Section 6(a)(1), as the Grand President, Grand Secretary and Grand Treasurer, respectively.
- (g) <u>Fiscal Year</u>: The fiscal year of the Grand Parlor Corporation shall begin on June 1st, and end on May 31st.
- (h) <u>Grand Parlor Year</u> (GPY): The Grand Parlor Year begins with the installation of a Grand President, and ends with the installation of his successor (typically from the Thursday following the third Monday in May, until the Thursday following the third Monday of the following May) per Article V, Part B, Section 5.
- (i) <u>Board of Grand Officers' Meeting</u> or <u>Grand Officers' Meeting</u>: The meetings of the Board of Grand Officers, as defined in Article V, Part B, Section 6(b).

Resolution 147-10 District Deputy & Supervising District Deputy Grand Presidents

WHEREAS the Constitution and Laws of the Grand Parlor, Article VI, Duties of Officers, Section 1(q) and Section 1(r), charge the Grand President with the duty to appoint District Deputies and Supervising District Deputies; and

WHEREAS the Constitution and Laws of the Grand Parlor, Article VI, Duties of Officers, Section 13, defines the duties of the Supervising District Deputy Grand Presidents; and

WHEREAS the Constitution and Laws of the Grand Parlor, Article VI, Duties of Officers, Section 14, defines the duties of the District Deputy Grand Presidents; and

WHEREAS there is currently no requirement that Supervising District Deputies belong to a Parlor within their assigned District except when making a temporary appointment at the Grand Parlor Annual Session; and

WHEREAS there is currently no prohibition upon a District Deputy belonging to his assigned Parlor; and

WHEREAS requirements for travel are placed upon the District Deputies and Supervising District Deputies, with no reimbursement of actual costs; and

WHEREAS there is currently no provision for a Supervising District Deputy to act as a District Deputy to one, or more, of the Parlors within his District,

NOW THEREFORE BE IT RESOLVED that the Constitution and Laws of the Grand Parlor, Article VI, Duties of Officers, Section 1(q), be amended as follows; and

Section 1. The Grand President shall:

- (q) appoint one Supervising District Deputy Grand President from each of the geographical districts set forth by counties as follows:
 - (1) The Supervising District Deputy must be a member of a Parlor within the District assigned him per Article VI, Section 13 of this Constitution.
 - (2) Should a Supervising District Deputy Grand President be unable to attend the Grand Parlor Annual Session of the appointing Grand President, the Grand President may appoint a District Deputy Grand President, or alternate member, from the District assigned to the absent Supervising District Deputy Grand President, to fill his position during his absence.

BE IT FURTHER RESOLVED that the Constitution and Laws of the Grand Parlor, Article VI, Duties of Officers, Section 1(r), be amended as follows; and

Section 1. The Grand President shall:

- (r) within fifteen (15) days after his installation, appoint District Deputy Grand Presidents to hold office at the will of the Grand President.
 - (1) No District Deputy Grand President shall be assigned to his own Parlor.
 - (2) The Grand President, at his prerogative, may instruct the Supervising District Deputy Grand Presidents to appoint the District Deputy Grand Presidents in their assigned districts,
 - (i) Said appointments will only take effect upon the approval of the Grand President;

BE IT FURTHER RESOLVED that the Constitution and Laws of the Grand Parlor, Article VI, Duties of Officers, Section 13, be amended as follows; and

<u>Section 13.</u> The Supervising District Deputy Grand Presidents shall:

- (a) shall be a member of a Parlor within the District he is appointed to, and
- (e) be reimbursed for mileage actual, reasonable, travel expenses in the performance of his required duties when attending Grand Officers' Official Visits to parlors within their appointed district, when mileage is in excess of 75 miles one way.
 - (1) Reimbursement shall be the same traveling expenses as set by the Committee on Finance for the Board of Grand Officers; *and*
 - (2) lodging and dining costs shall not be reimbursable.
- (g) Should a Supervising District Deputy Grand President be unable to attend the Grand Parlor of the appointing Grand President, the Grand President may appoint an alternate from the district assigned to the absent Supervising District Deputy Grand President.

BE IT FURTHER RESOLVED that the Constitution and Laws of the Grand Parlor, Article VI, Duties of Officers, Section 14, be amended as follows;

<u>Section 14.</u> The <u>District Deputy Grand Presidents</u>, after being duly appointed, shall each:

- (a) visit his assigned Parlor a minimum of the lesser of; two times, or one quarter of the Parlor's regularly scheduled meetings, in each six-month period; visit his assigned Parlor a minimum four times per year, once each quarter, with one visit being that of the Grand Officer's Official visit

 - (1) reimbursement shall be the same travelling expense as set by the Committee on Finance for the Visiting Board.
 - (2) lodging and dining costs shall not be reimbursable.
- (i) under extra ordinary circumstances, receive mileage claimed in the performance of his duties from his assigned Parlor.
 - (1) If a Parlor refuses to pay said claim, the mileage claim may then be directed to the Grand President by the District Deputy, and if, in the opinion of the Grand President, the claim is justified, he may order the claim paid from the Organization Fund.
 - (i) No claim for such mileage shall exceed the amount paid a Visiting Grand Officer in the performance of his duties.

NOW THEREFORE BE IT RESOLVED, that the Constitution and Laws of the Grand Parlor, Article X, Part A, Section 5(j), be amended as shown; and

- (j) <u>Organization Fund</u>, which fund shall be maintained by yearly appropriations voted at the annual session of the Grand Parlor.
 - (1) The Organization Fund *This fund* shall be used exclusively for the purpose of increasing the membership of the Order, and for the reorganization of delinquent Parlors and for no other purpose except as in this Constitution is otherwise provided.
 - (2) The Membership Committee shall have full and complete jurisdiction over the Organization Fund and no withdrawals are to be made therefrom except upon prior approval of a majority of its members.
 - (i) The Grand President shall be allowed to draw on the Organization Fund in any sum up to \$150.00 for any emergency without first obtaining the approval of the Membership Committee.
 - (ii) All withdrawals are subject to audit and approval of the Grand Parlor Committee on Finance.
 - (2) This fund shall be under the jurisdiction of the Membership Committee, subject to audit and approval by the Committee on Finance.

BE IT FURTHER RESOLVED, that the Constitution and Laws of the Grand Parlor, Article X, Part A, Section 5(t), be amended as shown.

- (t) <u>Contingency Expense Fund</u>, this fund which shall be financed by an annual appropriation of the Grand Parlor, and
 - (1) shall be no less than three percent (3%) of the approved annual budget, excluding that portion identified as the Grand Secretary's Office Budget.
 - (2) This fund shall be used for unexpected, non-budgeted expense items that may arise during a Grand Parlor term(s) as determined after review and approval by the Board of Grand Officers and the Committee on Finance; and
 - (i) The Grand President shall be allowed to draw up to \$500.00 for an emergency without first obtaining the approval of the Board of Grand Officers.
 - (3) Unused funds shall not roll over to subsequent years.
 - (4) This fund shall be under the jurisdiction of the Board of Grand Officers, subject to audit and approval by the Committee on Finance.

 - (1) Once the ballots have been destroyed, the results shall be final, and there shall be no further challenges of, nor changes to, the results.
- (c) The Recording Secretary shall record the results of the election, for all candidates, including the number of votes received by each candidate, including the runners-up, in the minutes of the parlor.

Proposed Amendment and new section to Article II, Membership in the "Constitution for the Government of Subordinate Parlors under the jurisdiction of the Grand Parlor of the Native Sons of the Golden West"

WHEREAS the membership of the Native Sons of the Golden West has been in a state of perpetual decline for the past several decades, showing in the past 21 years only five membership gains by PGP Jim Riley, PGP Richard Kimball, PGP Barney Noel, PGP Duane Gavin and lastly PGP Gene Perry; and

WHEREAS the systemic decline and hemorrhaging in the membership of the Native Sons of the Golden West has not been comprehensively or adequately addressed during this period with the exception of the terms mentioned; and

WHEREAS the COVID19 pandemic has brought the bleeding of membership to a fevered pitch and along with other mitigating circumstances has dropped the membership to an all-time low of 5,562 as of the close of the 2022/2023 membership term; and

WHEREAS if this drastic decline in membership is left unchecked, the trajectory of the membership will decrease from current levels to under three thousand members within a few short years which in all likelihood will increase per capita to over (100) one hundred dollars per member precipitating further membership loss and increasing per capita rendering the Order of the Native Sons of the Golden West financially unable to sustain its long and historical leadership role and stature in celebrating and preserving California History, Charitable contributions, and Historical Preservation endeavors, thus ceasing to exist and fading into history.

NOW THEREFORE BE IT RESOLVED that Article II, Membership in the "Constitution for the Government of Subordinate Parlors under the jurisdiction of the Grand Parlor of the Native Sons of the Golden West" be amended to add the following language to Article II, Section 1, and to add a new Section 8, Items (a) and (b) to read as follows:

Article II Membership

Section 1. Its membership shall be confined to citizens of the United States who were born within the state of California and those individuals stated herein *except as where otherwise stated*. Citizens born outside the state of California to parent(s) in the military who remain domiciled in California at that time and citizens born outside the state of California to parent(s) who are residents of California at that time, shall be regarded as having been born within the state of California. Beneficial members previously admitted shall retain all rights and privileges thereof. (138/6)

(a) Citizens of the United States who reside in California, will be eligible to be members of the Native Sons of the Golden West.

(b) All members from Section 8 item (a) will be billed dues and carried on the Parlor roster as members of that Parlor and will be afforded the same rights and privileges of all members of the Native Sons of the Golden West with exception of holding a grand office. A period of 10 years of membership must be met before a non-native member may run for Grand office.

California History Board

Worthy Grand President, Grand Officers, Past Grand Presidents, and Delegates, the California History Board (CHB) is pleased to make the following report to the 147th Grand Parlor.

During this past year, the CHB conducted in-depth research and authored, or edited, the text for numerous historical markers. We also researched and answered, or attempted to answer, several information requests from the public.

HISTORICAL MARKERS

Grand President Adams replaced several stolen plaques and rededicated another in its new location. Among these was the high-profile plaque, from 1917, marking the location of the 1859 Broderick-Terry Duel in, what is now, Daly City. The city wanted a monument that "makes a statement," and it does so with a granite plaque that stood taller than the Grand President.

Other high-profile dedications include a commemoration, in the Arcata airport, of William H. Snell, whose tragic death led to a legacy of improved helmet safety, and a plaque marking the Chinese Pioneer Cemetery in Auburn.

The CHB is working right up to the very end, and beyond, for Grand President Adams. At the time of this writing, one project is still in process:

Alamitos Ranchos (Los Cerritos and Los Alamitos)

In addition to those listed above, work continues to complete the replacement plaque for the Ranchos Los Cerritos and Los Alamitos in Long Beach. This plaque has been stolen twice since it was first placed in 1952. The project has been unfortunately hampered by unresponsive vendors and other factors.

I personally find it important to complete this dedication for Grand President Adams since no other proper dedications were arranged for him in Southern California.

This year, for different reasons, several projects could not be completed:

> Carson Mansion

Originally marked in the 1980s by Grand President Deal, the Ingomar Club (owners of the mansion) never installed the plaque because it contained erroneous information. The CHB is working with the Ingomar Club to produce a plaque that meets their approval. Due to the scheduling that will work best for them, this project is being held over for the incoming Grand President, Steve McLean. The erroneous plaque has been retrieved from the club, photo documented and will be destroyed.

> Thomas Gaines

Grand Parlor was approached by a local "historian" with finished text for a plaque honoring the first black resident of Antioch. However, while fact-checking, it was determined that her "history" largely consisted of flights of fancy. Her narrative collapsed entirely when another researcher's work cast substantial doubt upon the work and motives of the first person. It became obvious that there was a lot of local politics involved and the Native Sons did not need to wade into that mess. Upon the recommendation of the CHB, Grand President Adams declined to accept this dedication.

Mr. Gaines' story is one that should be told, but only if it can be done factually.

> Carmel Bakery

Although contacted by the owner to request this marker, and to provide information to us, despite repeated attempts, communication ceased after that for unknown reasons. Perhaps the project can be resurrected at a later date.

Dillon Beach

This dedication fell through for the most disappointing reason of all- our past, and the inability of narrow-minded individuals to realize that we are not the Native Sons of yore.

The California History Board respectfully requests attention to the preservation and digitalization of Grand and Subordinate Parlor archives by the upcoming Grand Presidents, Grand Officers, Parlors, and the Curator of Artifacts; to the preservation of our own history.

The Constitution and Laws of the Grand Parlor, and the Constitution for the Government of Subordinate Parlors, collectively known as "the Constitution," contain the rules by which the Order operates. The Constitution should be clearly and logically organized, with uniformity wherever possible. It should be easy to use and accessible to everyone, not obfuscated by murky language, bewildering organization and verbosity. It should not be some arcane document that is only intelligible to the initiated few, or that can be deliberately, misquoted, misrepresented, and misconstrued in its opacity, to be used as a cudgel with which to browbeat others.

The CRC has collaborated with the Committee on Laws of Subordinates to present twenty-nine resolutions for consideration at the 147th session of the Grand Parlor. These resolutions continue CRC's work to clarify, standardize, and organize the Constitution.

The committee looks forward to continuing to serve the Order in the coming year.

Also, the cost of litigation of claims continues to rise and affects the rising costs of insurance. There is not much we can do to keeping done the costs of insurance other than practicing good risk management and loss prevention at our locations and events.

REPORT OF SDDGP, PGP JAMES KING, DISTRICT 3

Worthy Grand Officers, Past Grand Presidents, and Delegates to the 147th Grand Parlor, here is my report on District 3 and its parlors.

The overall health of District 3 continues to decline. This report contains no moonbeams or fairy dust.

San Luis Obispo Parlor #290 – This parlor continues to struggle with general disinterest in the Order among its members and is now little more than a supper club.

While Richard Brown has repeatedly stated his desire to retire as the Parlor's president, not one single Brother has stepped up to relieve him. Grand 3rd Vice President Nelson has been helping with the preliminary planning for some activity that will attract outsiders and raise our visibility in the community. When the time comes, we will need much help from our friends.

Recommendations – District 3 has not had an initiation since 2017. I strongly suggest that the Grand President schedule one as soon as can be organized.
